SYNOPSIS OF ACTIVITIES AND FUNCTIONS

The Chamber runs fund raising activities each year with the dual purpose of raising funds for the Chamber's activities whilst at the same time providing community events for the general benefit of the Town. Such events recently are the Fun day run on the first Sunday in May each year, the Bingo Evening, and the British Legion music gig. The Chamber also supports events organised by others in the Town, with donations, for example the Firework Display organised by the Football Club, and with practical support, for example the Vintage Sports Car Club Welsh Trial weekend.

The Chamber runs fund raising activities each year with the dual purpose of raising funds for the Chamber's activities whilst at the same time providing social events for the benefit of members and their friends. There have been Cheese and Wine evenings, Woodland Barbeques, Magic Lantern Evenings.

The Chamber arranges a "works" visit each year to a local business. In recent years we have been to The Powys Observatory, and French's foundry. The Chamber arranges talks on subjects of interest. Recently we had a very interesting talk by the Space Guard Centre, about the impending pending threat of near earth objects colliding with our planet.

The Chamber finances and installs the Christmas lights each year, an increasingly onerous task, requiring the Chamber to comply with a very strict code of practice, in respect of structural, electrical and traffic management issues.

The Chamber runs the "Presteigne Llanandras Christmas Fair" each year. This is a loss-making event run for the benefit of the Town. In recent years, rather than being specifically targeted at increased shop sales on the day, it has been seen as jolly party in the High Street intended to encourage a welcoming atmosphere in the High Street that will engender loyalty in potential shoppers throughout the year.

The Chamber involves itself in and represents the views of members with respect to issues that are felt important. Recent issues have been car parking charges, town signage, refuse disposal, traffic movement issues. The Chamber provides a forum where issues of concern to members can be discussed.

The Chamber is a recognised body that is able to communicate officially with the Presteigne and Norton Town Council, Powys County Council, and other Local and National Government bodies in connection with issues of concern to members.

The Chamber has for many years been responsible for producing promotional literature and leaflets for the Town. Recently it has been the instigator and founding member of the new Tourism Promotion Association, which produces a Town Tourism Leaflet and a Town Trail each year and is responsible for the creation and running of the Presteigne and Norton Website. This is a new facility which has been set up to promote Presteigne and Norton and the surrounding areas from a Tourist point of view. This website is also seen as an increasingly useful source of information for local people.

CONSTITUTION

(FOUNDED MARCH 1989) (REVISED APRIL 2006)

- 1) **NAME:** PRESTEIGNE CHAMBER OF TRADE, COMMERCE AND INDUSTRY
- 2) **AIM:** To promote and safeguard the trading and commercial interests of Presteigne and to encourage new trade for the benefit of the area.
- 3) **MEMBERSHIP:** Shall be open to persons engaged in trade, commerce and industry and any other persons interested in contributing to Presteigne Chamber of Trade, Commerce and Industry.
- 4) **OFFICERS:** To be elected each year at the Annual General Meeting.
- 5) **SUBSCRIPTIONS:** To be reviewed annually at the Annual General Meeting. To be payable by 1st May each year. The Presteigne Chamber of Trade, Commerce and Industry reserves the right to remove members who have not paid their subscription fees from the register.
- 6) **NEW MEMBERS:** New members do not need to be elected. Anyone interested in joining may attend meetings and will become members on payment of subscription fees.
- 7) **ANNUAL GENERAL MEETINGS:** Shall be held on the first Monday in April each year.
- 8) **CHEQUES:** To be signed by two of the three officers, i.e. Chairman, Treasurer or Secretary.
- 9) **CONSTITUTION:** Any changes or amendments shall be made at the Annual General Meeting or at an Extraordinary General Meeting called for that purpose.
- 10) **HONORARIUM FOR SECRETARY:** Shall be reviewed annually and agreed by members.
