(2) Webinar re public accessibility and word/pdf documents: It was agreed that the Clerk attend the course at a cost of £30.

(3) Review of Allocated and Free Reserves and Budget Monitoring to end December: Members considered the budget update and reviewed the allocated and free reserves held. The Clerk answered questions on both documents and confirmed that the free reserves were a little above the minimum three months

expenditure recommended and had some leeway for use as part of the 2020/21 budget. This was considered sufficient given that allocated reserves were held towards major Council projects/services.

Members noted the allocated reserve for the renewal of Christmas lights was low and would consider adding to that reserve in future years.

It was agreed that the allocated reserve for Presteigne and Norton Trust be re-allocated as a reserve for the town website which had been taken over by the Council in November. It was noted that £276 costs had already been incurred.

Cllr. Wilding noted the balance in the allotment account and suggested that this could be used for additional grass cutting around the site to reduce the vole population. It was agreed that this be further discussed at a later date.

Mid Border Arts to be asked to consider broadening the use of the building as much as possible.

Existing Projects:

The amount for PACDG street cleaning was reduced to £250 given the current allocation was still not spent by the Group and £362 remained in the current year.

The amount for the running of the public toilets was reduced by £1000 to £9000 with the balance of £1000 to be funded from the allocated reserves for toilets. The specific toilet reserve to be reviewed again when setting the 2021-22 budget with a view to possibly reducing the allocated toilet reserve to one year's expenditure.

New Projects 2020/21: Members considered the new projects put forward and agreed the following for 2020-21 -

No amount was allocated to the Community Composting Proposal as it was understood that various voluntary groups were likely to provide funding. Discussion on the use of Went's Meadow for the site would take place at a future Council meeting.

Nothing was allocated for the Tri-Towns Chronicle (Council already has a monthly newsletter) or for payroll software (given that no Members had taken the allowance the current free software was adequate).

The quoted cost of £900 for additional Silia Wood signage was felt to be too high and no amount was allocated.

No amount was allocated towards tourist information signage as it was understood that surplus Trust monies had been transferred to PACDG and it was felt this could be used.

£2000 was allocated for devolved services. The £2000 in the current budget to be placed in an allocated reserve.

The draft budget suggested by the Sites and Buildings Committee for the Meadows was amended with the MUGA/ Barn reserve reduced by £1000 to £2000 (as in 2019-20) as it was felt works for the barn would be unlikely in the early years and the £1000 allocated for tree works was removed and would come from Meadow reserves.

A total budget of £70,888 was reached and it was agreed to set the precept for 2020-21 at £55.00 per Band D property per year. This represented an increase of £0.86 per year. (1.6%) on 2019-20.
