(3) Budget and Precept for 2019/20: Members then considered the budget for 2019-20.

Cllr. Bennett left the room for the discussion on the donation towards Presteigne Youth Project. Administration Costs:

No amount required for Councillor Remuneration as the amount allocated in 2018-19 had not been used and would be kept as an allocated reserve.
