(4) Review of Allocated and Free Reserves and Budget Monitoring to end December: The Clerk explained the various allocated reserves, the projected spend to the end of the financial year and the estimated free reserves at the year end which would equal approximately three months expenditure. The general reserve for the public toilets was considered to be more than absolutely necessary and it was agreed to consider the use of some of this towards running costs in 2023-24 when setting the budget.

It was agreed to remove the Greenfield Road roundabout from the management project and only continue with the Corton roundabout.

Administration costs were agreed as £33,915 and the amount for the maintenance and running of Went's Meadow £12,075.00.

This produced a budget of £77,325 and with the use of £4400 from the toilet's reserve toward spending on the public toilets this resulted in a precept requirement of £72,925.

It was agreed to set a precept of £54 per Band D property, raising £72,937.80, the same amount per property as in 2021-22 and 2022-23.
